Company Programme

Our flagship programme enabling young people aged 15-19 to set up and run a student start-up business over an academic year with regular support from an experienced Business Adviser.



Day Programmes

To inspire, challenge and enable students to discover more about themselves, their life choices, careers, the qualifications they might need, and develop key skills valued in the workplace.



Team Programme

An enterprise journey for students with learning difficulties; enabling students to gain skills, knowledge and experience in preparation for the transition from education into independent living and employment.



Start-Up Programme

Students aged 18-30 in further or higher education can set up and run their own start-up student company, giving them the opportunity to develop employability skills and business skills.



Fiver/Tenner

In teams, students are pledged £5 / £10 and have one month to make as much social impact and/or profit as possible by setting up and running a business.



Centres of Excellence

We set up, recognise and reward schools who are committed to a 'whole school' approach, developing excellence in financial education in the school's curriculum.



My Money Week

A national activity week for primary and secondary schools that provides an engaging opportunity for young people to gain the skills, knowledge and confidence in money.
